<b>2. Hazards identification</b> AIREX® T90/T92 does not constitute any risk to public health and environment if it is used as intended. Fine dust is produced while sawing, milling, grinding and sanding. Molten product adheres to the skin and causes burns. May contain residuals from physical blowing agent (hydrocarbons).
<b>3. Composition / Information on ingredients</b> Rigid polymeric foam on the basis of Polyethylenterephthalate.
<b>4. First aid measures</b> <i>Inhalation of gases in case of fire:</i> Move victim to fresh air and obtain medical attention. <i>Skin contact:</i> Molten product on the skin should be cooled rapidly with cold water, but not pulled off. Obtain medical attention. <i>Eye contact:</i> Flush with water if irritation develops. <i>Ingestion:</i> No special measures required. Seek medical attention if symptoms develop.
